4. During deliberations on the proposals, the FAC issued the following directions for observance by the concerned.


- i) In the Forest Land Diversion cases involving saplings and poles in the alignment, the Forest Department shall transplant the saplings and poles in dia class of 10-20 cm to nearby forest areas in particular degraded forest areas and the User Agency shall pay the cost for transplanting the saplings and poles. The transplanted saplings and poles will be monitored till their establishment.
- ii) The User Agencies shall strictly adhere to the instructions issued by the FAC/Forest Department wherein they have been asked to consult the Forest Department at the project conceptualization stage to ensure working out proposals/ alignments which involve bare minimum felling of trees as far as possible, and undertaking compensatory afforestation over alternate land in lieu of diversion of forest land and overall preservation of flora and fauna.
- iii) The Monitoring Committee shall closely monitor the works being undertaken in the forest areas.
- iv) The Forest Department shall place in the next FAC Meeting the action taken report on the establishment of Preservation Plot to be maintained by the State Forest Research Institute (SFRI) at Compartment 06/M,07/M, 8/M and 9/M in Batote and Bhaderwah Forest Divisions respectively as per the direction issued in the 111th FAC meeting, in the next FAC meeting.
- v) For the Forest Land Diversion cases which have to be completed in various Phases under PMGSY (i.e I, II and III) and require phase wise clearance of FAC, the User Agencies and Forest Department shall furnish the status of compliance of the conditions imposed by FAC while clearing proposals relating to earlier phases.
- vi) The Forest Department shall depute a team of officers/officials drawn from the Forest Department and PMGSY alongwith environmental experts to Himachal Pradesh to study the best practices/procedures followed in




safeguarding the flora coming in the alignment of road projects in terms of the provisions of the Forest (Conservation) Act, 1980.
