AUCTION NOTICE FOR SALE OF RESIN STOCKS.

DATE & VENUE:

 Auction for the sale of resin stocks shall be held on 28th of April 2016, (Thursday) from 11:30 A.M onwards at Forest Information Centre, Bikram Chowk, Jammu.

QUANTITY:

2. The quantity to be put for sale has been notified separately; Copy whereof can be had from the office of the Chief Conservator of Forests, Jammu on any working day between **20**th April to **27**th April 2016 (except on holidays).

DESCRIPTION OF MATERIAL:

3. Details about the resin available for sale depot-wise and weight in metric tonnes will be issued in the shape of annexure before the start of auction. The intending bidders can collect a copy of list on the spot before commencement of auction. The auctioning authority of the J&K Forest Department reserves the right to withdraw, combine or split lot(s) or to alter the composition of lot(s) specified in the lot list before commencement of the bid as per requirement of the department, without prior notice or without assigning any reason thereof. The resin stocks are stored in depots falling in the jurisdiction of Ramnagar. Udhampur, Billawar, Rajouri, Nowshera, Mahore Divisions.

ELIGIBILITY OF PARTICIPATION:

In accordance with the new resin policy:

4. All interested persons, irrespective of the fact whether they are "resin processing unit holders" or not, are eligible to take part in auction

MODE OF CONDUCTING OF THE AUCTION:

- 5. It shall be an open auction where only such bidders shall be allowed to participate who have been issued entry passes. A maximum of two representatives of a party shall be allowed to enter the auction venue and participate in the auction.
- 6. Every participant will bid for the material in lots mentioned in the para 2 and 3 above. The highest bid shall be accepted on the fall of hammer. The department, however, reserves the right to reject any offer or withhold the sale without assigning any reasons thereof. Objections if any raised by the intending bidders shall not be entertained. The rate offered by the bidder shall be exclusive of all taxes of State/Central Government. State Sales Tax and Surcharge will be levied on the amount of basic cost and Central excise

duty combined together.

BASIC COST AND TAXES:

At the payable basic amount computed on the basis of accepted bid and quantity of oleo-resin stocks purchased by the successful bidder, sales tax at the existing rate of 20% of basic amount and 5% surcharge on sales tax, as well as Central Excise Duty at the rate of 12.50% of the payable basic amount shall be charged from the successful bidder before the release of stocks as per rules. On the basic cost, 12.50% Central Excise duty will be levied. On the gross amount after levying Central Excise, 20% Sales Tax and 5% Surcharge will be levied.

Income tax shall be paid by the bidder himself as per rules applicable and department has no responsibility in this regard.

The rates of state/central tax are as per existing tariff and if Government makes any change within the period of final payment by successful bidder, these shall be levied accordingly.

TERMS OF PAYMENT:

- The intending bidders shall be required to deposit earnest money in the shape 8. of CDR/Bank Draft drawn in any Government recognized/Scheduled Bank of India, payable at Jammu, pledged to or in the name of Chief Conservator of Forests, Jammu @ Rs. 20,000/- per lot of 9.00 MT. In no case the bidders without CDR/Bank Draft shall be allowed to participate in the Auction. Further, Banker's Cheque/Local Cheque shall not be accepted at any cost. In case of unsuccessful bidders, their earnest money shall be released on the spot and in case of successful bidders, it shall count towards the cost of resin. The successful bidders have to deposit 10% of the bid money on the fall of the hammer. In case the successful bidder fails to deposit 10% bid money (the bid money includes the basic cost plus taxes) on the fall of hammer, the rate shall be offered to the second highest bidder who shall be given opportunity to deposit 10% bid money. This amount can be deposited in the shape of CDR/Bank Draft on any Government recognized/Scheduled Bank of the country, payable at Jammu and pledged to or in the name of Chief Conservator of Forests, Jammu. The CDR/Demand Draft shall be adjustable towards the total cost of the material purchased and the balance 90% of the bid money (the bid money includes the basic cost plus taxes) shall be deposited by the successful bidder in similar manner within 21 days from the date of auction for obtaining release order from the Chief Conservator of Forests, Jammu. The Forest Department shall make arrangements for setting up of counter by any one of the Scheduled Banks at the venue of the auction on the said date for collection of CDR/Bank Draft against cash deposits made by the participants of the auction.
- 9. The earnest money shall be forfeited in case of such bidders who do not deposit the 10% bid money immediately after the fall of hammer.
- 10. In case the successful bidder does not deposit 90% of the bid money by the scheduled time i.e., within 21 days from the date of auction, an interest of 25%

per annum shall be charged for the belated payment for a further period of 15 days. If the payment is not made even within this extended period of 15 days, the 10% bid money deposited by the bidder shall be forfeited by the undersigned and the material shall be disposed off by the department without giving any notice to the party.

DELIVERY/LIFTING OF THE AUCTIONED MATERIAL:

- 11. The successful bidder after having deposited 10% of the bid money (the bid money includes the basic cost plus taxes) on the fall of the hammer and balance 90% of the payment within due date shall be given formal allotment letter for the quantity purchased by him against which the material shall be lifted by him from the respective depots of the concerned Forest Divisions on "As it is where it is" basis within 15 days of the issue of the allotment order or the date on which full payment is received in the office of the Chief Conservator of Forests, Jammu, whichever is earlier. It will be responsibility of the successful bidder to collect copies of allotment orders from the office of CCF, Jammu and the department will not be responsible for any postal delays or postal losses if the allotment order is sent to them by post. The bidders shall be bound to lift each lot having a quantity of 9 MTs or in its multiples, of Oleo-Resin in one truck in one go. The material shall be supplied in tins after allowing uniform tare of 1Kg, per tin irrespective of its packing capacity.
- 12. The stocks shall be lifted by the successful bidders within a period of 15 days from the date of issue of allotment letter in his favour, which may be extended further upto 30 days depending upon the quantity of the resin involved, on the sole discretion of the CCF Jammu. After the expiry of this period, further request for extension shall be considered after imposing a penalty of Rs. 50/-per quintal per month.
- The Forest Department, J&K Government shall in no case be responsible for making arrangements for transportation etc., of resin.
- 14. Resin tins purchased by the bidders shall be at the risk and responsibility of such bidders after the issue of the allotment orders in his favour and the Forest Department shall not be responsible for any loss of the material due to theft, fire, pilferage, sabotage or any other reason including natural calamity.
- 15. Resin purchased by the successful bidders shall be permitted to be processed only within the State of J&K in their own processing units except in case of the parties from outside the J&K State.
- 16. Forest Department reserves all rights to inspect any time the factory or resin stocks or products like Rosin and Turpentine processed by the parties. The Forest Department also reserves the right to check the records and accounts of such resin processing units in order to compare the out-turn vis-a-vis the quantity of resin procured by them.

GENERAL:

- 17. Any dispute arising between the purchaser and the Forest Department shall be resolved by the Chief Conservator of Forests, Jammu, whose decision shall be final and binding on both parties.
- 18. Court proceedings, if any, connected with the sale of oleo/resin by open

auction on the notified date shall be subject to the jurisdiction of the courts at Jammu.

- Any other condition, if found necessary shall be announced before the commencement of the auction on the notified date.
- 20. It shall be in the interest of bidders to inspect various depots before making any bid for purchase of resin. It shall be deemed that the bidders have inspected the resin for which they have offered their bid. And in no case any complaint about quantity/quality of resin purchased by them in the auction shall be entertained.
