

Sir,

The Steering Committee of J&K CAMPA, in its meeting held on 08 February 2022, while approving the APO 2022-23, gave certain directions to the department. A copy of the minutes is enclosed for reference. Inter alia, the committee directed the department to prepare additional APO in respect of following activities for approval of the Chairman of the Steering Committee on file:

- i. For protection of forests vulnerable to encroachment, the activity of fixing Boundary Pillars needs to be further scaled-up. In this regard, the Department should prepare additional APO for erecting boundary pillars to cover such areas in a time bound manner.
 - ii. Additional APO shall be prepared for comprehensive eco-restoration of forest areas around Patnitop-Nathatop (Sanasar) road, in a phased manner. APO for any other required allied activity, including research, may also to be put up.
2. Accordingly, it is requested that additional APO in respect of above activities may please be prepared and submitted to CAMPA Secretariat within two weeks time i.e. by 19 March 2022.
3. Besides, appropriate action may be taken on other decisions/directions of the committee, as recorded in the minutes, and reported to CAMPA Secretariat. It may be noted that CAMPA Secretariat is duty-bound to submit action taken report on the directions of the committee in its next meeting.
