Sir/Madam,

The Supplementary Annual Plan of Operations (APOs) of J&K CAMPA regarding liabilities of Financial Year 2019-20, which arose due to COVID-19 related lockdown in March, 2020, have been approved by the Executive Committee of National Authority, Ministry of Environment, Forest & Climate Change, Government of India in its 13th meeting held on 7 June 2021.

2. Now actual requirement of funds against those works of FY 2019-20 which were executed and bills raised, but payment could not be made due to sudden lockdown related to COVID-19 pandemic may be resubmitted by 23 July 2021 for release of funds. It may be noted that a committee headed by CCF (P&P) has already submitted a list of such works vide No.PCCF/Plg/2020-21/686-89 dated 15.07.2020. Bill for any work not included in the list cannot be raised at this stage.
