Sanction is accorded to the constructions of service reservoirs and pump Room by the public Health Engineering Department on the forest land detailed as under on the terms and conditions given against each:-

1. Construction of service reservoirs with a capacity of 5000 gallons on the forest land measuring one kanal in comptt. 40/Nowshera.
 - i. The land will be transferred to the PHE at a cost of Rs. 1.00 lac.
 - ii. The PHL Deptt will not damage any tree growth.
 - iii. The Proposed structur will be completed as per the approved design and no alterations or extensions are carried out without the permission of the Forest Department.
 - iv. The PHE Department will Pay an amount of Rs. 5000/-towards compensatory afforestation for double the area (viz 2 kanals). The amount involved will be deposited with the Forest Department. The trees so planted will be the property of the Forest Department.
 - v. The PHE Deptt will ensure that no forest growth is damaged in around the area while laying out the pipe lines.
2. Construction of pump Room 15,000 gallons, reservior at Hidayatpora W.S.S. Doghani on the forest land measu-ring one kanal.
 - i. The PHL Deptt shall pay for the compensatory afforestation at the rate of Rs. 10,000/-per Hectt.
 - ii. The PHE Deptt shall pay cost of the land as will be determined by the Collector.
 - iii. The PHE Deptt shall construct retarning walls, pucca drains drainage wherever suggested by the forest Deptt to protect the area from erosion.
3. Construction of 5000 gallons service reservoir at Kharsan on the forest land measuring one kanal in comptt. 50/Ncw WSS Bhowni.
 - i. The PHL Deptt shall pay for the compensatory afforestation at the rate of Rs. 10,000/-per Hectt.
4. Constructions of reservoirs at:-
 - a/ Chika Kota WSS gabyog
 - b/ WSS Shahpur Site Tala
 - c/ WSS Pada Kanthol Kalakote
 - d/ WSS Codhar
 - i. The PHE Deptt shall pay for the compensatory afforestation at the rate of Rs. 10,000/-per Hectt.

- e/ Kuma gali WSS Gadyog ii. The PHE Deptt shall pay cost of the land as will be determined by the Collector.
f/ WSS site Palma Dodhar Kandi
g/ Thandapami Compt 31/Now iii. The PHE Deptt shall construct retaining walls, puca drains/drainage wherever suggested by the Forest Deptt to protect the area from erosion.
h/ Comptt 40/Nowshera
