**Subject:-** Diversion of Forest Land for construction of Storage Reservoir Karma in Nowshera Forest Division

**Reference:-** Cabinet Decision No. 105/8 dated 07.06.2005.

**GOVERNMENT ORDER NO: 282/FST OF 2005**  
**D A T E D 16 - 06 - 2005**

Sanction is accorded to the diversion of forest land measuring 1425 Sq.ft falling under Compartments No. 52/D of Forest Division Nowshera for construction of Storage Reservoir Karma, by the PHE Deptt. on the following conditions:-

- i. The proprietary status of the forest land shall remain unchanged.
- ii. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- iii. The forest land so diverted shall not be mortgaged, re-assigned or sub-leased by user agency in any manner whatsoever to any other agency.
- iv. The user agency shall pay compensation of land as assessed by the Revenue authorities alongwith the assessment report furnished by the competent authority.
- v. Any damage done to the forest by the user agency or its employees, contractors or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 as penalty.
- vi. The forest land so diverted shall return to the Forest Department, when it is not required by the user agency without any cost.
- vii. The user agency shall deposit the amount of compensation for the forest land, and compensation of damage done, if any, with the DFO concerned.

The proposal stands cleared/approved by the Advisory Committee in its 29<sup>th</sup> meeting held under the Chairmanship of Chief Secretary on 06.06.2005.
