Diversion of Forest Land for construction of Safawali Gutumderi read (Km 22.50 to KM. 36,00) Kehmil Forest Division.

Government Order No: 398 FST of 2005

Dated: 4-15.05

Sanction is accorded to the diversion of forest land measuring of 22.25 Hectares falling under Compartment No.21-22/Jagran Keran of Block Keran, Range Keran of Kehmil Forest Division for construction of Safawali Gutumdori road by GREF on the following conditions:-

- The proprietary status of forest land shall remain unchanged.
- The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay Net Present Value of Forest land 22.25 hac., as would be assessed by the concerned DFO as per Hon'ble Supreme Court Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No. 202 of 1995 T.N. Godavarman Thirumlakpad V/S Union of India.
- 5. The User Agency shall be bound to pay an amount of Rs. 1, 60, 48,000/- on account of compensation of 1156 number of trees/poles of different species and dia-classes.
- 6. The User Agency shaft pay Rs: 7, 47,200/- on account of compensatory afforestation to be carried over 44.50 ha.
- The extraction of trees shall be done by the State Forest Corporation/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan Circle.
- Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
- The user agency will construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.
- 10. The forest land so diverted shall return to the Forest Department when it is no longer required by the User Agency without any cost.
- The user agency shall get done Environment Impact Assessment and also prepare the Environment Management Plan as provided under Environment Protection Act.
- 12. The money on account of various heads to be paid by the user agency as detailed above shall be deposited with Chief Accounts Officer in the office of PCCF.

The proposal stands cleared/approved by the Advisory Committee in its 30th meeting held under the Chairmanship of Chief Secretary on 16.8.2005.
