GOVERNMENT ORDER NO. 88 -EST of 2005
D A T E : 21.02.2005

Sanction is accorded to the diversion of forest land
measuring 7.40 Hectares of forest area falling under state
Land (Forest Plantation Closure) of Block Banihal, Range
S.C. Range Banihal, and Division Ramban Forest Division for
construction of Mehar-Neera road by R&B Division Ramban on
the following terms and conditions:-

1. The proprietary status of the land shall remain unchanged.
2. The user agency shall pay Rs. 1,45,000/- towards
compensation of 88 trees of different species and dia
classes at two times standard rate of 1992.
3. The user agency shall pay Rs. 1,70,000/- towards
compensatory afforestation scheme.
4. The user agency shall construct complete retaining/breast
walls on both sides of the road and take other necessary
steps so as to minimize soil erosion/land slips.
5. The extraction of trees shall be done by SFC/Forest Deptt.
on the basis of the marking list duly approved by the
Conservator of Forests, Working Plan Circle.
6. Any damage done to the forest by the user agency or its
employees, contractors or people employed by them shall be
charged from the user agency @ ten times of the standard
rate of 1992 as penalty.
7. The user agency shall deposit the amount of compensatory
afforestation in the office of POCF J&K Govt. as per
provisions of SRO-203 of 2000 dated 13.06.2000. The
compensation of trees and compensation of damage done, if
any, shall be deposited with the DFO, Ramban.

The proposal stands cleared/approved by the Advisory
Committee in its 28th meeting held under the Chairmanship of
Chief Secretary on 03.02.2005.
