Subject: Diversion of Forest Land at Wahidpora for construction of Filtration Plant and Reservoir.

Reference:- Cabinet Decision No. 04/Cir dated 31.01.2006.

GOVERNMENT ORDER NO. 49 - FST OF 2006D A T E D : 0 - PST OF 2006

Sanction is accorded to diversion of forest land measuring 2.43 Kanals falling under Compartment No. 23/Kandi in Block Harwan, Range Kandi, Kamraj Forest Division for construction of Filtration Plant and Reservoir at Wahidpora by the Executive Engineer, PHE Division, Handwara on the following terms and conditions:

- 1. The proprietary status of forest land shall remain unchanged.
- 2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay Net Present Value of forest land 2.43 kanals as would be assessed by the concerned DFO as per Hon'ble Supreme Court Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No: 202 of 1995 T.N.Godavarman Thirumlakpad V/S Union of India.
- 5. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
- 6. The forest land so diverted shall return to the Forest Department when it is no longer required by the User Agency without any cost.
- 7. The money on account of various heads to be paid by the user agency as detailed above shall be deposited with Chief Accounts Officer in the office of PCCF.

The proposal stands cleared/approved by the Advisory Committee in its 30th Meeting held under the Chairmanship of Chief Secretary on 16.08.2005.
