Subject :-Diversion of Forest Land for construction of Irrigation Canal Manthar to Gohan.

GOVERNMENT ORDER NO. 5^2 - FST OF 2006DATED2006DATED.02.2006

Sanction is accorded to diversion of forest land measuring 6.871 Ha falling under Compartment NOs. 2,4,5,6,7,8, and 9/Kuthar in Block Dandipora, Range Daksum, Anantnag Forest Division for construction of Irrigation Canal Manthar to Gohan by Executive Engineer, Irrigation Division Anantnag on the following terms and conditions:-

- 1. The proprietary status of forest land shall remain unchanged.
- 2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay Net Present Value of forest land 6.871 ha. to the tune of Rs. 47,60,000/-
- 5. The User Agency shall be bound to pay an amount of Rs. 4,36,980/- on account of compensation of 187 Nos. of trees of different dia-classes.
- 6. The User Agency shall pay Rs. 1,56,000/- on account of compensatory afforestation to be carried out over 13.742 ha.
- 7. The extraction of trees shall be done by the SFC/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan Circle.
- 8. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times of the standard rate of 1992.
- 9. The user agency will construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.
- 10. The forest land so diverted shall return to the Forest Department when it is no longer required by the User Agency without any cost.
- 11. The User Agency shall also any other amount which will be come payable as per Hon'ble Supreme Court Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No: 202 of 1995.
- 12. The user agency shall get done Environment Impact Assessment and also prepare the Environment Plan for submission of same to Forest Department before taking up of actual execution of work.
- 13. The mode of payment of compensatory afforestation shall be according to Compensatory Afforestation Fund Management and Planning Authority (CAMPA) and shall be communicated later on.
