Subject:- Diversion of Forest land for construction of road Tringulian to Basantgarh in Udhampur Forest Division, Udhampur.

Sanction is hereby accorded for diversion of 0.4 ha of forest land under Forest (Conservation) Act of 1997 in Comptt. No: 57/Bgh of Udhampur Forest Division in District Udhampur for construction of road from Tringulian to Basantgarh in favour of PWD (R&B) on the following terms and conditions:-

1. The proprietary status of forest land shall remain unchanged.
2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
4. The user agency shall pay compensation of land on account of change of land use which shall be equivalent to cost of land as assessed by Revenue Authorities.
5. The user agency shall pay Rs. 18,23,980/- on account of compensation of trees to be felled @ two times of the standard rate of 1992. (87 trees)
6. The user Agency shall pay Rs.10000/- towards Compensatory Afforestation for planting ten times the trees felled.

7. The extraction of trees shall be done by Departmentally.
8. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from user agency at the rate of ten times the standard rate of 1992.
9. The user agency will construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.
10. The forest land so diverted shall return to the Forest Department when it is not required by the user agency without any costs.
