

Sub:- Diversion of forestland for non-forestry purpose favouring PWD Department for construction of Road passing through Forest Area in Compt.2/Peoni Km Chountra Mata Thial road.

FOREST ORDER NO <sup>EST</sup> 10 OF 2002.  
D A T E D : - 18 - 07 - 2002.

Sanction is hereby accorded for diversion of 1.75 ha of Forestland under section 2b(ii) of Forest (Conservation) Act of 1997 in compt. In 2/Peoni of Jammu Forest Division in District Udhampur for construction of Chountra Mata Thial road by PWD on the following condition of terms and conditions.

1. The proprietary status of forestland shall remain un-changed.
2. The forestland so diverted shall be utilized on for the purpose for which it has been diverted it shall not be transferred to any other agency without approval of Forest Department.
3. The forestland so diverted shall not be mortgaged, re-assigned or sub-leased by user agency in any manner, whatsoever to any agency.
4. The user agency shall pay Rs. 312305/= on account of compensation trees.
5. The user agency shall pay compensation of land on account of change of land-use as assessed by Revenue Authorities.
6. The user-agency shall also pay Rs 60000 on account of compensatory afforestation to be done over 3.0 ha degraded forestland.
7. The felling of trees shall be done departmentally for disposal at Sale Depots.
8. Any further damage done to the Forest by the user agency or its employees and contractors, people employed by them shall be charged from user agency at the rate of 10 times the standard rate of 1992.
9. The user agency will construct complete retaining / breast walls on both sides of the road and take other necessary steps to minimize soil erosion / landslips.
10. The forestland so diverted shall return to the Forest Department when it is not required by the user agency without any costs.
