
Sub: Diversion of 0.18 hectares (3 Kanal 13 Marlas) Forest Land for construction of link road Thalella - Bhella - Parnote (Phase -I) by PWD in Comptt. 26/Ch of Bhaderwah Forest Division.

Sanction is hereby accorded for diversion of 0.18 hectares (3 Kanal 13 Marlas) forest land under section 2b (ii) of Forest (Conservation) Act of 1997 in Comptt. No: 26/Ch of Bhaderwah Forest Division in District Doda for construction of link road Thalella - Bhella - Parnote (Phase -I) by PWD on the following terms and conditions:-

1. The proprietary status of forest land shall remain unchanged.
2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
4. The user agency shall pay Rs. 54000 on account of cost and compensation of trees felled by user agency.
5. The extraction of balance trees shall be done Departmentally and timber utilized in timber sale depot.
6. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from user agency at the rate of ten times the standard rate of 1992.
7. The user agency will construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.
8. The forest land so diverted shall return to the Forest Department when it is not required by the user agency without any costs.
