Sanction is hereby accorded for diversion of 1.30 Ha forest land under under section 2b (ii) of Forest (Conservation) Act of 1997 in Comptt. No:13-14/K of Bhaderwah Forest Division in District Doda for construction of Neota-Manwa Dispensary road by PWD (R&B) Division in Bhaderwah on the following terms and conditions as laid down below:-

The proprietary status of forest land shall remain unchanged.

The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.

3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any

manner what so ever to any other agency.

The User Agency shall pay compensation of land amounting to Rs.3,22,200/- on account of change of land use as assessed by the Revenue Authority.

The User Agency shall pay Rs.11,11,008/- on account of compensation of 137 trees of different species

and Dia-classes @ two times of the standard rate of 1992.

- 6. The User Agency shall pay Rs.1.00 lacs on account of compensatory afforestation to be carried over
- 7. The extraction of trees shall be done by State Forest Corporation/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan & Research Circle 8. Any damage done to the forest by the user agency or its employees and contractors or people employed

by them shall be charged from user agency at the rate of ten times the standard rate of 1992.

9. The user agency will construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.

10. The forest land so diverted shall return to the Forest Department when it is not required by the user

agency without any costs.

11. The forest land so diverted shall return to the Forest Department when it is no longer required by the

User Agency without any cost.

12. The User Agency shall Deposit the amount of Compensation for the forest land, compensation of trees and compensation of damage done, if any, with the DFO, Bhaderwah and the amount of compensatory afforestation shall be deposited to the Chief Accounts Officer O/o Pr.Chief Conservator of Forests.
