Sanction is hereby accorded for diversion of 1.925 Ha. forest land for the construction of Reasi to Kiyala road by PWD (R&B) Division, Reasi falling in Compartment No. 36 of Reasi Range of Reasi Forest Division under J&K Forest (Conservation) Act Section (2) Sub-Section 1(a) tause (ii) on the following terms and conditions:-

1. The proprietary status of the forest land shall remain unchanged.

2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.

3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.

4. The user agency shall pay Rs. 4,37,500/- compensation of land on account of change of land use which shall be equivalent to the cost of land as assessed by Revenue Authorities.

5. The user agency shall pay Rs. 3,69,184/- on account of compensation of 473 number of trees of different species s @ two times of the standard rate of 1992.

- 6. The user agency shall pay Rs.2,61,270/- towards compensatory afforestation including expenditure for relocation of existing closures to be carried over 3.855 Ha. of degraded forest land.
- 7. The user agency shall construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slides.
- 8. The extraction of trees shall be done by SFC/Forest Department on the basis of marking list duly approved by Conservator of Forests, Working Plan Circle.
- 9. Any damage done to the forest by the user agency or its employees, contractors or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 a. penalty

10. The forest land so diverted shall return to the Forest Department when it is no longer required by the user agency without any costs.

11. The Juser agency shall deposit the amount of compensatory afforestation in the office of the Pr. of Conservator of Forests,, J&K Govt. as per SRO-203 dated 13-04-2000
