Sub :- Forest clearance for improvement/widening of road Domel - Jindra - Kharta between Km. 00 to 0.86 and Km. 26.00 to 29.00 to N.H two lane specifications.

Forest Order No: 03A FC of 2004
Dated :- 15 / 03 / 2004.

Sanction is hereby accorded for diversion of 1/2 Ha. forest land for the improvement/widening of road Domail-Jindra-Kharta between Km. 00 to 0.86 and Km. 26.00 to 29.00 to N.H two lane specifications by GREF falling in Compartment No. 2, F and 7, F of Jindrah Range of Jammu Forest Division under J&K Forest (Conservation) Act Section (2) sub-Section 1(a) clause (ii) on the following terms and conditions :-

1. The proprietary status of the forest land shall remain unchanged.
2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
4. The user agency shall pay Rs. 51,446.30 on account of compensation of 55 number of B/I trees at two times of the standard rate of 1992.
5. The user agency shall construct complete retaining/breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/land slides.
6. The extraction of trees shall be done by SFC/Forest Department on the basis of marking list duly approved by Conservator of Forests, Working Plan Circle.
7. Any damage done to the forest by the user agency or its employees, contractors or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 as penalty.
8. The forest land so diverted shall return to the Forest Department when it is no longer required by the user agency without any costs.
