Sanction is hereby accorded for the diversion of forest land to the extent of 1.547 Ha. for construction of Ludnoo Bridge Dugnu Dhar road (RD Km 3rd to Km 7th) by P^fD in Comptt.No:31/BLR and 32/BLR of Billawar Forest Division strictly under the provisions of J&K orest Conservation Act on the following terms and conditions:-

The proprietary status of the forest land shall remain un-changed.

The forest land so diverted shall be utilized only for the purpose for vich it has been diverted. It shall not be transferred to any other agency without approval of the Fost Department.

The forest land so diverted shall not be mortgaged, reassigned or subased by user agency in any

manner what so ever to any other agency.

4. The User Agency shall pay the Net Present Value of the land to the 1e of Rs.12,65,446/- as per Hon'ble Supreme Court Order Dt:30.10.2002 in I.A. No: 566 in W Petition (Civil) No: 202 of 1995 T.N. Godavarman Thirumalpad V/s Union of India.

The User Agency shall be bound to pay an amount of Rs.12,41,15(on account of compensation

of 752 numbers of trees/poles of different species and dia-classes.

The user agency shall be bound to pay an amount of Rs.77,350 n account of Compensatory Afforestation to be carried over double the area diverted i.e.3.094 II

7. The extraction of trees shall be done by State Forest Corporation/Fst Department on the basis of marking lists technically sanctioned by Conservator of Forests Worg Plan and Research Circle and administratively approved by Chief Conservatof Forests, Jammu.

8. Any damage done to the forest by the user agency or its emptes and contractors or people employed by them shall be charged from user agency at the rate len times the standard rate of

1992.

9. The user agency shall take all necessary steps to check soil eion likely to occur due to the intending construction of road.

10. The forest land so diverted shall return to the Forest Departmente of any encumbrances when it

is no longer required by the User Agency.

11. The user agency shall also pay any other amount which willcome payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K

12. The user agency shall submit an undertaking that in case of aupward revision of rates of Net Present Value, the user agency will pay the amount of differentialet Present Value.

13. The user agency shall be responsible to obtain requisite clearancunder any other law in vogue.

14. The money on account of various heads to be paid by the usegency as detailed above shall be deposited with Chief Accounts Officer in the office of PCCF.
