Terms and Conditions applicable

- 1. The proprietary and legal status of forest land shall remain uncharged
- The User Agency and / or its contractors will not bring any forest land under their use, other than the actual area approved in the instant proposal. Any laxity or deviation on this account by the User Agency or its contractors will attract penal provisions of the relevant acts/ legal provisions.
- 3. The forest land shall be utilized only for the purpose for which it has been indented.
- 4. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any there agency.
- 5. The User Agency shall pay the additional amount of NPV, if so determined as per decision of the Hon'ble Supreme Court of India
- 6. (i) The extraction of the trees/poles shall be done by the State Forest Corporation/ Divisional Forest Officer concerned on the basis of marking administratively approved by the Chief Conservator of Forests, Jammu. The marking for tree felling will be done in consultation with the user agency and effort shall be made to save maximum number of

trees/poles/saplings. The cost of extraction shall be paid by the User agency directly to the agency executing the extraction.

- (ii) The fundamental rule of marking of trees, enumerated during processing of the proposals, will be to save maximum number of trees without compromising with the construction and maintenance of the approved project structure and no trees/poles/saplings will be felled/cut/pruned/lopped for purpose/project activities other than those approval/sanctioned.
- 7. The User Agency shall construct retaining / breast walls on forest land and take all necessary steps to check soil erosion.
- 8. The User Agency shall ensure that Mulba is dumped either at identified place within the forest land proposed for diversion or shall arrange the dumping of Mulba outside the
- 9. Any damage done to the forest by the User Agency or its contractors shall be charged from the User Agency @ 10 times the standard rate of 1992.
- 10. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.
- 11. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- 12. The amount of Rs.20,00,000/-(Rupees twenty lacs only) against the due amount of Rs. 29,52,316/- (Rupees twenty nine lacs fifty two thousand three hundred and sixteen only) on account of various heads as detailed in summary table stands deposited by the user agency in the account of the Chief Accounts Officer under intimation to Nodal Officer FCA, in the office of the Principal Chief Conservator Forests, J&K. Since the User Agency has shown utmost urgency vide their letter No. E.E/R&B/Nsr/6446-48 dated 06-\$\infty\$03-2017 and assured to clear the outstanding at an earliest, accordingly this sanction is hereby issued, however, if the User Agency failed to liquidate the outstanding, their any future proposal shall not be considered till they clear the balance of Rs. 9,52,316/-(Rupees nine lacs fifty two thousand three hundred and sixteen)
