Sub:- Cancellation of land diversion issued under FC Order No. 07-FC of 2010 dated:- 19.02.2010

Whereas on the recommendation of CCF, Jammu vide letter No. CCF-J/FCA/121/1821-26 dated:- 04.02.2010, 0.06 ha. forest land was allowed for construction of Rain Water Harvesting and Water conservation structure by 7 SIKHLI in Nowshera Forest Division vide this office order No. 07 FC of 2010 dated: 19.02.2010.

Whereas the mentioned user agency viz Army has neither taken over the allowed land nor made any payment as asked for vide above mentioned FC order.

Whereas the CCF, Jammu via his letter No. CCF-J/FCA/43-45 dated:- 15.04.2017 has intimated that the user agency has requested for cancellation of the land diversion for Construction of Rain Water Harvesting and Water conservation structure by 7 SIKHLI allowed under order No. 07-FC of 2010 dated: 19.02.2010 and accordingly the outstanding be reduced against the user agency.

Now in view of the above given details and as recommended by CCF, Jammu, the land diversion to the extent of 0.06 ha allowed under above mentioned FC order is hereby cancelled and the unpaid amount of **Rs. 1,38,300/-** shall be reduced from the overall outstanding against the user agency and accordingly the corresponding figure of overall diverted forest land shall get reduced by 0.06 Ha.
