For and on behalf of the Governor of J&K State, sealed tenders affixed with revenue stamp of Rs. 5/- are invited from contractors duly registered with the Forest Department for the right of extraction/collection and removal of Gucchies *Morchella esculenta* (Morels) from the demarcated / undemarcated and Berune line Forests of Udhampur-Ramnagar and Billawar Forest Divisions under the jurisdiction of East Circle, Jammu during the year **2015-16**. 
