# MINUTES OF THE 84<sup>th</sup> FOREST ADVISORY COMMITTEE MEETING HELD UNDER THE CHAIRMANSHIP OF SH IQBAL KHANDEY IAS, CHIEF SECRETARY, JAMMU AND KASHMIR, AT CIVIL SECRETARIAT, SRINAGAR, ON 09/06/2014.

## I. Following general directions were also given by the Committee:-

a. It was noted that Index Map submitted by the User Agencies are vague and don't have sufficient information. It was decided by the committee that besides a good quality colour coded Index Map, a GPS based map on KMZ file should also be submitted with the proposals.

- b. User Agencies will ensure that muck is disposed off only on the designated sites. Number and locations of the dumping sites should be rationalized keeping in view the length of road.
- c. A system of monitoring of the proposals approved under the Forest Conservation Act needs to be in place. Task of monitoring may also be assigned to the third party agencies at the cost of User Agency. Monitoring may also be conducted through the State Government departments.
- d. User Agencies will seek guidance from the Department of Soil Conservation for the soil conservation works during execution of the project.
- e. On the issue of the development of technique for the transplantation of conifer saplings in forests by the State Forest Research Institute, it was decided that Forest Department will arrange a visit of Sh S.P.S. Dutta, member (FAC) to the Research site of SFRI.
- f. The Chairman directed that Commissioner/ Secretaries of the concerned departments should also be invited in the meeting as special invitee.

### Agenda Item No. (2)

Status of payment of outstanding amount pending against various User Agencies was presented by the Member Secretary and following decisions were taken;

- i. FAC observed that progress of outstanding payment is slow and User Agencies should make the payment due against the sanctioned cases. Unless outstanding amount is cleared, proposals of the respective User Agencies should not be processed.
- ii. It was decided that in case, payment is not received within one year of the sanction of a proposal, approval should be considered as deemed to have been withdrawn and process for formal cancellation of order should be initiated.
- iii. Payment in one case "Loran- Oranpathri Kuliyan Road" has not been processed by the Chief Engineer, SAMPARK (BRO), as it is the BADP deposit work and payment in this case is to come from the State Government. It was decided that matter should be taken up with the Planning department.
- iv. Proposal of MD, SPDC for cancellation of forest clearance in cases, in which forest land is not required by the agency, should be placed before the FAC. Fresh proposal of Baglihar HEP should also be processed.
- v. All cases under which forest land has not yet been utilized due to nonavailability of money in the scheme or due to nonrequirement of land and payment is still outstanding, a proposal for the cancellation of clearance may be put up before the Committee.

## Agenda Item No. (3)

A presentation on the report of the committee constituted by the Pr. Chief Conservator of Forests for monitoring of the Chenani –Nashri Tunnel (NHAI) was made by the Member Secretary. Following process was followed for the monitoring of the project;

- I. User Agency was requested vide letter no. PCCF/FC/1355/2221-23 dated 07/11/2013 to submit a report on the compliance of the terms and conditions imposed in Government sanctions given for the project.
- II. Project Director, NHAI submitted detail compliance report vide no. PD/JMU/Leighton/Vol-VI/93 dated 17/01/2014.
- III. Monitoring team under the Chairmanship of the Addl. Pr. Chief Conservator of Forests (P&P) visited the project on 13<sup>th</sup> March 2014.
- IV. Based on the observations of the committee, User Agency was requested to furnish some documents vide no. PCCF/FCA/1355/3378 dated 15/03/2014, which was furnished by the NHAI vide letter no. PD/JMU/Leighton/Vol-VIII/13-14/575 dated 28/03/2014.

Based on the compliance report submitted by NHAI, observations of the monitoring team and the reply of the NHAI, findings of the monitoring of "Chenani-Nashri Tunnel" is as under;

After detail deliberation following observations were made by the FAC;

- I. FAC showed concern on the failure of retaining walls and that the quantity of Muck exceeded by 60% than the original calculation and the information was not shared with the Forest Department nor were any timely measure taken for acquisition of land for the muck disposal.
- II. It was also observed that the original estimate that the 30% of the Muck would be reused in aggregates was also wrong as the encountered rock is mostly not suitable for aggregates based on stipulated technical specification requirement. It shows deficiency in the survey and investigation work including the geological investigation done before the start of the project.

The Forest Advisory Committee expressed its concern on the miscalculations and faulty designs in the implementation of the project and it was decided that findings of monitoring of the project will be shared with the Ministry of Surface Transport and Ministry of Environment and Forests, Government of India.
