MINUTES OF THE 96th MEETING OF THE FOREST ADVISORY COMMITTEE HELD UNDER THE CHAIRMANSHIP OF SH. B.R.SHARMA IAS, CHIEF SECRETARY, JAMMU AND KASHMIR, AT CIVIL SECRETARIAT, JAMMU ON 14.02.2017.

The 96th meeting of the Forest Advisory Committee (FAC) constituted under the J&K Forest (Conservation) Act, 1997, was held under the chairmanship of Sh. B. R. Sharma IAS, Chief Secretary, Jammu and Kashmir Government, at Civil Secretariat, Jammu on 14th February, 2017.

At the outset Commissioner/ Secretary to Government, Forest, Ecology & Environment Department informed that under "The J&K Forest (Conservation & Afforestation) Rule, 2000, the PCCF has to certify that he has considered all other alternatives and that no other alternative in circumstances are feasible and that the required area is the minimum needed for the purpose. He also informed that the PCCF is required to send the proposals to the administrative department alongwith particulars specified in the annexure to the said rules for their placement before the FAC through Member Secretary. He further stated that the indenting departments or authorities requisition of an equivalent area and afforestation therefore. It was decided that the issues raised by the Commissioner/ Secretary Forest Department will be separately examined before the next meeting of the Forest Advisory Committee.
