In continuation to Forest order No 150 of 2023 dated 14-06-2023 and on the recommendation of the J&K Services Selection Board and endorsed by the Administrative Department vide their letters referred above, sanction is hereby accorded to the temporary appointment of below mentioned candidates as Junior Assistants (UT Cadre) in the Forest Department, in the pay level 4 (25500-81100), notionally w.e.f 14-06-2023:-

The appointees shall report to the Office of Principal Chief Conservator of Forests, J&K, Jammu/Srinagar within a period of twenty one (21) days from the date of issuance of this order failing which he/she shall forego his/her right to appointment, and the same shall be deemed to have been cancelled ab initio without any further Notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- Academic/Qualification Certificates.
- Matriculation/Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by the Competent Authority.
- Valid relevant Category Certificate, if any, applicable.

The appointment of the above candidates shall further be subject to the following conditions:

- a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found fake/forged his/her appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- b. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in Such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from her salary. DDO Concerned shall obtain an affidavit from the Concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of these appointee shall not be drawn and disbursed to his/her unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agency.
- d. The appointees shall be on probation for a period of two years and shall undergo and qualify the Secretariat Assistant Examination (Foundation Course) during the period of probation.
- e. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the above appointees shall be on the basis of the merit secured by these appointees as recommended by the J&K Service Selection Board.
- g. The cadre allocated by the appointing authority/JKSSB shall not be changed under any circumstances
- h. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
