Protection of Forests from various damages, encroachment, forest fires etc. is becoming challenging and problematic in some vulnerable pockets. In order to strengthen the mechanism for providing regular directions, guidance and for monitoring of protection related activities, a Forest Protection Cell under the overall control of CCF S&D is created with immediate effect which shall look after and coordinate the Forest Protection related activities of Forest Department besides tracking of cases handled by Direction Office. The constitution of the Cell is given as under:-

The Cell shall be supported by Coordination Section of Office of PCCF & HoFF.

The Forest Protection Cell shall look-after the following:-

- To keep record and follow up of all damage cases ordered to be enquired by Direction Office.
- To coordinate Forest Protection related activities like creation of Joint Control Rooms, Model Check Posts, Modernization etc.
- To enhance use of technology for prevention and control of Forest Damages.
- Mapping of vulnerable areas to Forest Encroachment and Forest Damage.
- To provide assistance to PCCF & HoFF in all Forest Protection related areas.
- Any other task assigned by the PCCF & HoFF.
