# Sub: "Har Gaon Hariyali" Campaign of Forest Department

The Government of Jammu & Kashmir has initiated ten point campaign to ensure effective implementation of flagship and other government schemes at the grassroots level. The progress of such campaigns are being reported periodically from the O/o Dy. Commissioners of all the 20 districts and copy of one such report is enclosed herewith. "Har Gaon Hariyali" is the campaign assigned to Forest and sister departments with a target to cover all the "Village Panchayats" and planting of one crore saplings. The following points may kindly be noted for whole hearted participation in the campaign on "Har Gaon Hariyali".

- Planting under all schemes, viz; CAMPA/CAPEX/One Beat Guard, i) One Village Program/Green India Mission, etc. be included as all the plantings within or outside forests is being carried out with the consultation and involvement of Village Panchayats.
- The achievements of monsoon planting divisions may also be ii) incorporated as the planting has already been accomplished. The winter planting of such divisions may be reported periodically as per directions of the Government in this regard.
- All DFOs (Territorial) located at District Headquarters shall combine iii) the planting achievements of all the Forest and sister departments engaged in planting under all schemes and report to the Dy. Commissioners concerned as per the mechanism developed at district level.
- All Conservator of Forests (Territorial) being the Controlling Officers of DFOs (Territorial) and Head of the Circle level Coordination Committee shall ensure that no Village Panchayat remains uncovered from the Government campaign on "Har Gaon Hariyali". They have already been directed vide this Office No. PCCF/Plg/28B/4477-83 dated 17.11.2021 to ensure coverage of all Village Panchayats under 'Green J&K Drive' through 'One Beat Guard, One Village Program' with the involvement of all sister departments.
