Circular 05 of 2020
Dated 08-6-2020

The Government of Jammu and Kashmir has notified the J&K Forest Produce Transit Rules, 2020. Under Rule 5 (4) of the said rules, a printout of E-Way bill generated from the Goods and Services Act E-Way bill system shall be deemed to be a transit permit issued under these rules. The rule however makes other provisions governing transport routes, retention of the transit permit and inspection of vehicles and checking of the forest produce in transit, applicable for consignments of forest produce being transported under the E-Way bill. In order to effectively implement these provisions, the officers are instructed to adhere to the following instructions.

a. Divisional Forest Officers (DFO)

The DFOs shall instruct the officers in charge of the check posts and ensure proper use of Form 26 at the notified check posts for recording the transit of forest produce under the E Way bill. The format for the entry of data in Form 26 is enclosed as Annex A to this circular

b. Range Officers

The Range Officers shall submit a monthly consolidated statement of Form 26 maintained for the transit of forest produce under Form 25/ E Way bill system to the DFO concerned. The format for the report is enclosed as Annex B to this circular.

c. Forest Officers in charge of check posts

The forest officer in charge of the check post shall exercise all such inspection as they do for transit under Form 25, hither to fore. After checking the forest produce, the forest officer in charge of the check post shall record on the printout of the E-Way bill under his signature, date and time with the word "CHECKED."
