C I R C U L A R

WHEREAS, the combined Tentative Seniority List of Multitasking Staff (MTS)/Class IVth officials of **District Cadre Baramulla (Kashmir North Circle Sopore)** as it stood on 01-01-2025 was notified and circulated among members of the Service vide notification bearing No:FD/CFN/Admn /2025/T.Sen.List/1768-83 Dated: 15-02-2025;

WHEREAS, a time period of 15 days, from the date of issuance of the tentative seniority list, was provided to the concerned for filing of objections if any, to the seniority positions assigned to them, category status(s) or otherwise;

WHEREAS, stipulated time period has already expired and during the intervening time, the representations from various officials through their DDOs were received by this office. These representations were examined on merits and extant rules in position. The details of these representations vis-à-vis decisions given under rules are reproduced hereunder:

1. Representation of Sh. Mohd Jamal Mir (Watcher) for enlisting his name in the seniority list of District Baramulla instead of District Kupwara:

Representation made by the concerned official, received through DFO Langate vide his No. DFO/LGT/Estt/ 2024-25/2451 Dated 05-11-2024, was examined and during the course of examination, it has been ascertained that the official has initially been engaged as Daily Wager in North Circle Office and subsequently regularized as Helper in the same office and subsequently re-designated as Watcher as verified from his Service Book and other supporting documents, so the representation made by the official has been considered on its merits and name of the official has been deleted from the seniority list of MTS officials of District Kupwara and enlisted in the seniority list of MTS officials of District Baramulla at appropriate position.

2. Representation of Sh. Ramesh Kumar Pandita (Watcher) for enlisting his name in the seniority list of North Circle:

A representation was made by the concerned official regarding inclusion of his name in the seniority list of MTS officials of North Circle and after examining the case file of the official, he has been transferred from Demarcation Division-I Jammu to Kashmir North Circle Sopore along with post vide Forest Order No. 266 of 2009 Dated 17-11-2009 issued by the Principal Chief Conservator of Forests, J&K Govt under endorsement No. PCCF/ NG/ Helper/ 1357-64 Dated 17-11-2009. The request has been considered on the basis that the official migrated from the valley during the peak turmoil in early 1990s and being borne on the establishment of Forest Department.

AND WHEREAS, after issuance of the tentative seniority list(s), several changes have also occurred on account of promotion(s), retirement(s)/death(s) and the names of such officials need to be included/ excluded from the respective categories of the seniority list(s).

NOW THEREFORE, the Final Combined Seniority List of Multi-Tasking staff (District Baramulla) borne in Forest Divisions JV Forest Division/Uri CAT-II) borne on schedule cadre (Orderly, Farash, Chowkidar, Mali, Cattle Pond Keeper, Boat Mazdoor, Chain Man, Water Carrier, Road Mazdoor, Mapper, Watcher, Jamadar & Gardener) as it stood on 01-01-2025 forming Annexure to this Circular is hereby issued for information of all concerned officials.

The Dates of Birth recorded against the officials is provisional and are always subject to verification with original Date of Birth Certificates/ Service Books. The Drawing and Disbursing officers shall ensure that the seniority list is circulated among all the Class IVth (MTS) Officials working under their control so that they are apprised about their seniority position.

The Final Seniority list is issued without prejudice to the outcome of the writ petitions(s), if any, pending before any competent court of law.


