Whereas, the tentative seniority list of **Chauffeurs and Drivers Grade-I (Senior Grade Divers)** of Kashmir Region as it stood on **01-01-2024** was notified vide this Office notification bearing endorsement No:CCF(K)/Admn/2023/Chau & Drivers-I/2861-85 dated: 19-12-2023 for information of all concerned;

Whereas, it was inter-alia provided in the abid notification:-

- I. *That any Official not satisfied with his / her position in the tentative seniority list or the left out Chauffeurs and Drivers Grade-I (Senior Grade Divers), if any, may represent to this Office through his / her Drawing and Disbursing Officer with documentary evidence within a period of 21 days from the date of issuance of the notification. In case no representation was received within the stipulated time, it would be presumed that there was no objection to the position(s) assigned to the Official(s) in the tentative seniority viz-a-viz there was no left out incumbent and accordingly the seniority list would be finalized;*
- II. *That in case Official(s) belonging to reserve category/ies, were desirous to update the category status in the seniority list, he/she may submit the self-attested copy of valid category certificate through his/her drawing & disbursing Officer within the stipulated time period of 21 days;*


Whereas, the stipulated time period of 21 days has already expired and during the intervening time, no objection or representation from Chauffeurs and Drivers Grade-I (Senior Grade Divers) of Kashmir Region has been received by this Office. However, one Shri. Mehraj- ud Din has vide representation dated: 21-12-2023 represented for fixation of his seniority among the Drivers Grade -I. In this connection, it is to state that the promotions as Driver Grade-II and Driver Grade-I granted to the said representee were pending clearance by the Departmental Promotion Committee, which has not been accorded his case is still under examination as per the directions issued by the PCCF & HoFF under communication No. PCCF/NG/Estt/C-7345146/3395-96 dated: 29-11-2023, the representee cannot claim a place in the seniority list of Chauffeurs and Drivers Grade-I (Senior Grade Divers) of Kashmir Region until a final decision in his case is taken Divisional Level Departmental Promotion Committee Kashmir.

The Dates of Birth recorded against the Officials are provisional and are always subject to verification with original Date of Birth Certificate / Service Book.




