### C I R C U L A R .

Whereas, the tentative seniority list of Junior Assistants of District Cadre Kashmir as it stood on 01-01-2024 was notified vide this Office No: CCF(K) /Admn /2023 /Sen. JAs/Distt-Cadre/2836-60 dated: 19-12-2023;

Whereas, it was inter-alia provided in the abid notification: -

- I. *That any Official not satisfied with his / her position in the tentative seniority list or the left out Jr. Assistant (District Cadre), if any, may represent to this Office through his / her Drawing and Disbursing Officer with documentary evidence within a period of 21 days from the date of issuance of the notification. In case no representation was received within the stipulated time, it would be presumed that there was no objection to the position(s) assigned to the Official(s) in the tentative seniority viz-a-viz there was no left out incumbent and accordingly the seniority list would be finalized;*
- II. *That in case Official(s) belonging to reserve category/ies, were desirous to update the category status in the seniority list, he/she may submit the self-attested copy of valid category certificate through his/her drawing & disbursing Officer within the stipulated time period of 21 days;*

Whereas, a time period of 21 days, from the date of issuance of the tentative seniority list, was provided to the concerned for filing of objections, if any.



The Dates of Birth recorded against the Officials are provisional and are always subject to verification with original Date of Birth Certificate / Service Book.


